**Revenue**

1. For November 2013, revenue was as expected.
2. The Town is starting to receive property taxes for real estate from the County. The first large payment from the County was received last week.

**Expenditures**

1. During November the Fire Department purchased approximately \$7,500 of bunker gear for the first line firefighters. This expenditure was budgeted for FY 2014.
2. All other expenses were as expected.
3. The cost of the relocation and operation of the temporary Town Hall as of November 2013 was \$292,400. The cost of the temporary Town Hall is approximately \$4,000 per month. A spreadsheet is attached to this report with a description of all the expenses incurred.
