Points of Interest  
January 2015

**Revenue**

1. Revenue was as expected for January 2015.
2. The Town has received over half the projected property tax revenue for this fiscal year.
3. Water and Sewer revenue is as projected for FY 2015.
4. The Town has received over \$225,000 in hospitality tax revenue during FY 2015. This equates to approximately 90% of the amount budgeted to be transferred to the General Fund for this fiscal year.

**Expenditures**

1. Most expense accounts were as expected for January 2015.
2. Garbage disposal for the Town is up for the year and it appears the account will be over budget. This is due mainly to the additional pick-ups over the holiday weekends during the summer.
3. The cost of the relocation and operation of the temporary Town Hall as of January 2015 was \$357,000. The cost of the temporary Town Hall is approximately \$4,000 per month.
4. The cost for the design and construction of the Town Hall as of January 2015 was approximately \$326,000.
