4. Before entering the pool area, residents will be required to sign in and pay the normal guest fee to the Club for all those over the age of three (3) years.
5. Dependants of the resident under the age of thirteen (13) must be accompanied by their parent(s) or guardian over the age of twenty-one (21) years. The guardian must have written permission from the parent before the will be allowed to sign in.
6. Residents are discouraged from inviting non-resident guests; however, the invitation of one or two non-residents may be permitted at the discretion of the Club Coordinator or his designee.
7. All residents are expected to obey and abide by all regulations pertaining to pool use as set forth by the South Carolina Department of Health and Environmental Control (DHEC) while on premises.
8. All residents are expected to obey and abide by all house rules as set forth by the Club while on the premises.
9. ANY violations of the rules and regulations may result in immediate loss of pool privileges for that day and possibly the denial of all future privileges.
10. Residents will observe and comply with all rules, regulations and laws now in effect or which may be enacted, during the continuance of this Agreement by any municipal county, state or federal authorities having jurisdiction over the premises, and to indemnify the Club and SCE&G for any damage caused by violation thereof in accordance with the terms of this Agreement.
